Ways to Pay Your Pledge

If you are looking for different ways to pay for your pledge, we have many options for you outlined in the table below.

Online payments: If you use the Saltwater website,

(https://saltwaterchurch.org/stewardship/donate/) you can set up payments through PayPal as a one-time payment or a recurring monthly payment. Our online payment form also offers the ability to make a one-time payment directly from your bank account or credit card; however, switching to a paper check (personal or bank checks) will save the church up to \$100/year in credit card processing fees.

Checks: You can send us a personal check with a notation in the memo line that is for your pledge. You may put your check in the basket as it is passed around on Sunday or drop it off/mail it to the church office: 25701 14th Pl S, Des Moines, WA 98198. Many banks now offer paper checks via bill paying services at no cost, however our current system does not allow for the use of other electronic payment services like Zelle for pledges. Both types of checks can be used for any frequency of payment.

Investments: If you are hoping to pay your pledge using retirement funds, stock transfers or investments monies, please speak directly with your financial advisor or investment firm. You can pledge directly from your investment account, use your required minimum distribution from your IRA (for a nontaxable charitable donation) or you can transfer stock. These types of payments can be set up for monthly, quarterly, annual or one-time withdrawals.
